Biographical Information Overview of Interview: Lieutenant Colonel (LTC) Lawrence H. Pickett was born in Berlin, Germany on December 16th, 1962 and spent his youth as an Army brat. His father was a Vietnam veteran and active duty Army officer. Pickett attended Western Kentucky University where he joined the ROTC program and attended airborne school. Commissioned in the infantry, he served his first overseas tour in Germany with the 8th Infantry Division (Mechanized). As part of the 101st Airborne Division, he participated in Operations Desert Shield and Desert Storm in 1990-1991. After leaving active duty in 1994, he joined a Civil Affairs Brigade, a U.S. Reserve unit in Homewood, Illinois, and later became an ROTC instructor at Western Illinois University. He deployed with the 308th Civil Affairs Brigade in the immediate aftermath of the invasion of Iraq in 2003. He volunteered to deploy again to Iraq in 2006, working again in Civil Affairs in Baghdad. In 2008-2009 LTC Pickett went to Nuristan Province in Afghanistan as part of a Provincial Reconstruction Team (PRT). In 2010 LTC Pickett began serving as an Assistant Professor of Military Science for the ROTC program at Western Illinois University.
