Biographical Information Overview of Interview: Bob Rogers was born in February, 1950 in Los Angeles, California, and grew up there, dreaming of a future in the movie industry. Following graduation from high school in 1968 he attended college while also finding work in Disneyland's Main Street magic shop. In that job, he began to learn all of the behind-the-scenes aspects of the entertainment business. In 1981 he founded his own business, BRC Imagination Arts, an exhibit design firm that has developed the reputation for its immersive and imaginative products, handcrafting experiences that engage an audience and bring a museum's subject to life.

In 1998 Rogers' firm competed with several others for the opportunity to develop the exhibits for a new library and museum for the Illinois State Historical Library's collection of Lincoln artifacts, what eventually became the Abraham Lincoln Presidential Library and Museum. The firm was selected by the Illinois Historic Preservation Agency (IHPA) Board of Trustees, then chaired by Julie Cellini. Susan Mogerman served as the director of IHPA at that time. For the next several years, BRC, in conjunction with Julie, Susan, Tom Schwartz (the state historian) and several others, collaborated on the design of what eventually became a revolutionary type of presidential museum. Their mission was to create a museum that would inspire visitors "with a greater attraction to and fascination with the life and times of Abraham Lincoln." Most of the interview involves Rogers' detailed discussion of the creative process for the museum's many exhibits, the challenges they encountered due to limited space and especially financial constraints, and the public's reaction to the museum's exhibits. He discussed the crucial role that Julie, Susan, Tom, Bob Coomer and others played throughout the process. He also discussed the museum's many life figures created by Life Formations, and the musical score created by David Kneupper, a renowned composer. This interview includes Bob's presentation and a Q & A session to an audience in Union Theater. A large number of museum volunteers were in attendance.
