Abstract

Biographical Information Overview of Interview: Jill Hutchinson was born on March 8, 1945 in the Bronx, New York. She graduated from Highland High School in Albuquerque, New Mexico in 1963. Afterwards, she attended the University of New Mexico and graduated in 1967 with a bachelor's degree. During this time, Hutchinson played Amateur Athletic Union basketball. In 1969, she earned a master's degree at Illinois State University, and in 1976 she earned a doctorate at the University of North Carolina at Greensboro. She is one of only a handful of coaches/players inducted into both the Women's Basketball Hall of Fame (2009) and the James Naismith Hall of Fame (2009) and is a member of the IBCA Hall of Fame. She also served three separate terms as the President of the Women's Basketball Coaches Association (1982 as the first person in the position, 1985 and an unprecedented third time in 1992).

In 1968 Hutchinson began coaching at the Illinois State University (ISU). While at ISU, Hutchison coached Charlotte Lewis, who became arguably one of the nation's premier players over time and one of only three basketball players at ISU to have their jersey retired. Lewis played on the 1976 United States Olympic Women's Basketball Team and went on to have an extensive basketball career overseas. Hutchinson helped to make all of this possible for Lewis by being her mentor as well as her coach. Hutchinson helped prepare Lewis to play on the Olympic team, and helped motivate her to earn her college degree.

In 2010¹, Hutchinson was interviewed about her experiences with Charlotte Lewis, who passed away of a heart attack in September 2007.
