Biographical Information Overview of Interview: Julie Cellini (born 1944 in Springfield, IL), Robert (Bob) Coomer (born 1945 in St. Louis, MO) and Susan Mogerman (born 1945 in South Shore, IL) were three of the key figures behind the creation of the Abraham Lincoln Presidential Library and Museum. The library opened in 2004, and the museum was dedicated on April 19, 2005, with a host of dignitaries participating in the opening celebration. On February 26, 2015 the three participated in a panel discussion commemorating the museum's tenth anniversary. The panel members talked about their many struggles over a period of nearly twenty years. They discussed their relationship with Bob Rogers, the founder and president of BRC Imagination Arts, and the creative process behind the design and creation of the museum's many exhibits. They addressed the key role that State Historian and Lincoln scholar Tom Schwartz played throughout that process, and also the difficulties in procuring the property and financing for the library and museum.

Julie Cellini spoke about the creation of IHPA in 1985, and the origins of the idea to find a better, more appropriate venue to display the state's extensive Lincoln collection. She also explained why the IHPA Board of Trustees selected Bob Rogers and BRC Imagination Arts to design the exhibits. Susan Mogerman talked about the group's initial experiences with Walt Disney Imagineering, with Bob Rogers and his designers, and about the many visits the group took to other museums around the country. Bob Coomer addressed the challenges they faced working with the architectural firm of Helmuth, Obata, and Kasselbaum, the BRC team, Central Management Services (CMS) and the many contractors who worked on the project.
