Biographical Information Overview of Interview: Jerry Harrison grew up in Virginia, Illinois, and earned a Bachelors Degree from Western Illinois University. He began his career in Pittsfield (circa 1982) teaching junior high school social science, science, and coaching. He also taught at Heyworth from 1983 to 1985. In 1986, Harrison began working with the Illinois Education Association (IEA). In 2011, he was named the IEA representative to the Classrooms First Commission, created by the Illinois state legislature and headed by Lieutenant Governor Sheila Simon. This Commission was given the task of looking at reorganization and efficiency options for school districts. The interview covers Harrison's experiences on the Commission. At the time of the interview in 2012 he served as Field Director for District #11, which covers school districts in Sangamon County.
