Abstract

Biographical Information Overview of Interview: Ralph Martire was born on July 25, 1959 in Bridgeport, Connecticut. He earned a BA in History from Indiana University in 1982, and a JD from the University of Michigan in 1985. Following graduation, Martire worked from 1986-2004 with three Chicago law firms. His area of focus was on intellectual property, corporate transactions, asset-based lending, technology patents, and as general counsel. In 1999 he became the Executive Director of the Center for Tax and Budget Accountability, a 501(c) (3) think tank whose stated mission is to ensure "state, federal, and local workforce, education, fiscal, economic, and budget policies are fair, just, and promote opportunity for all." Martire also currently serves as Vice-President for the River Forest District 90 and is a member of the executive board of the West Cook Division of the Illinois Association of School Boards. From 2011-2013, he was a full voting commissioner to the congressionally established "Equity and Excellence in Education Commission." This work led to the report "For Each and Every Child" in February, 2013. He also serves as a technical advisor to the House Appropriations Committee on Education Policy. In addition, Martire writes articles for statewide newspapers include the Springfield State Journal Register and the Suburban Chicago Daily Herald, and teaches classes at Illinois State University, Roosevelt University, and Benedictine University. Mr. Martire is a frequent guest on television talk shows discussing public policy.

This interview explores the issue of pension under-funding and how it developed over the years. Also discussed were the role that several changes played in the state's severe pension shortfall, including the Edgar Pension Ramp, various early retirement legislations, pension holidays and bond sales, the temporary income tax, Tier 2, and the passage (2013) and later unconstitutional ruling (2015) on Senate Bill 1. Martire talks in detail about the causes of pension underfunding, and potential solutions to the problem.
