Abstract

Biographical Information Overview of Interview: Mary Painter was born in Bloomington, Illinois in 1950, to parents Linden Painter and Florence Beecher Painter. Her father was a grain and livestock farmer and her mother a former teacher and community volunteer. They lived on a farm near Anchor, Illinois. Mary graduated from Octavia High School in 1968 and attended Eastern Illinois University for two years. She earned her BS in news-editorial journalism from Southern Illinois University in 1972. She married Brent Bohlen in 1970 and in 1972 they moved to Boston where Brent pursued his master's and law degrees. While there, she worked at Brandeis University and Lesley College. They moved to Springfield, Illinois in 1976, and Mary earned his master's degree in public affairs reporting from Sangamon State University in 1977. She was hired by United Press International, where she spent five years reporting on activities in the Illinois statehouse. Her tenure included the epic 1982 fight over the passage of the ERA. ERA never achieved adoption in thirty-eight states as was required by the U.S. Constitution. Brent and Mary had a son, William, in 1979, and adopted their daughter, Elizabeth, from South Korea in 1986. In 1985 she began a 30-year career as a professor of Communication and Public Affairs Reporting at Sangamon State University, which was reorganized and renamed the University of Illinois Springfield in 1995. Mary used her personal experiences as a reporter as a teaching tool. She still wrote for publications in her retirement and enjoyed spending time with her four grandchildren.

Mary was active in the Springfield chapter of Women in Communications for many years, including serving as its president. She also co-founded the Springfield chapter of the Association for Women Journalists and was a member of the Association for Education in Journalism and Mass Communication.
