Abstract

Biographical Information Overview of Interview: Michael (Mike) Monaghan was born in Chicopee Falls, Massachusetts in July, 1951. He graduated high school from Griffin High School in Springfield, Illinois in 1970, and went on to earn degrees from Lincoln Land Community College and then Bradley University in 1974. His field was mathematics and political science. Upon graduation from Bradley, Mike worked for the Illinois Secretary of State from 1974 to 1979. Monaghan also earned a master's degree in Legal Studies from Sangamon State University (now U. of Illinois-Springfield) in 1979. He then moved to work with the Senate Democrat staff for ten years, from 1979 to 1989. During this time, he worked with the Senate Pension Committee and the Pension Laws Commission as an analyst. In 1989, he joined the Illinois Community College System working as its Government Relations Director and in 2004 as the Executive Director for the Trustees Association.

In this interview, Monaghan discusses pension legislation from 1979 to 2016. Topics covered include early retirement options, the Rule of 85, COLA (Cost of Living Allowance) enhancements, the 1995 pension reform, Tier 2, the temporary income tax of 2011 to 2014, funding levels for pensions, the impact of recessions on pension investments, and Senate Bill 1. The interview covers how the budget stalemate in 2015 and 2016 has impacted higher education, especially community colleges. Monaghan also explored the possibility of pension cost shifting and the community college leaders' recent position on the subject. Possible taxing of pensions was also discussed. Finally, he covers how pension funding has been a negative impact on state budgeting over the past decade.
