# **Consent Items**

Minutes from July 20, 2022, Public Meeting

The Chairman welcomed the board, and members gave their condolences to Lincoln scholars and history supporters John Rowe and Cullom David.

# **Executive Director Report**

Earlier this month, we passed our core documents stage for museum accreditation.

The ALPLM is preparing for the final run of the *Stories of Survival* exhibit ending the second week in January 2023. The new exhibit will open in March 2023.

We opened our nursing suite with a great event and media coverage.

We will be participating in the Memorial downtown Holiday Walks again this year and will be free to the public on Wednesday and Saturday nights during December.

#### **Chief of Staff report**

Since the last board meeting, the ALPLM has onboarded several new employees in many departments. Former employee, Ralph Miller, is temporarily filling in as our Director of Facilities. We are conducting interviews for the Development Director position.

The ALPLM is preparing for AFSCME master contract negotiations and the FY24 budget.

We are working closely with the Governor's office to update our DEI plan.

The ALPLM is working on updating our parking garage to an electronic payment system.

# **Chief Operating Officer report**

The education department continues its community outreach and programs that offer CPDU credits.

In the library department, several of our paintings had condition surveys done on them. All the Lincoln portraits were in good condition. The department continues working on our 3D scanning project and preparing for the Taper collection transfer.

# **Chief Legal Officer report**

Please complete Ethics training by the end of November.

By October 31st, the Taper collection will transition from the ALPLM to the Lincoln Presidential Foundation. They have hired a consultant that will be at the ALPLM for three days packing and removing the collection. The Foundation didn't provide information about where the artifacts will go or where they will be stored. Our staff has been diligently working with them to ensure our end of the loan agreement, and our care for those artifacts extends until the last day they are here. We are very proud of the professionalism of our staff during this removal process.

## **Chief Fiscal Officer report**

The fiscal team closed out FY22 which ended in July. The team is working on budget requests for FY24.

The ALPLM has gone live with online payments. With online payments, we can accept payments on our website for donations, library services, and venue rentals.

The fiscal team is now fully staffed with the addition of Jo Barnhart and intern Ezekiel.

#### **Public Information Officer report**

The ALPLM receives positive coverage of the nursery room and the Jason Benetti event. One of our social media posts of a Lincoln quote went viral.

## **Director of Research and Interpretation report**

The Illinois History Conference last week had 157 attendees, eight vendors, and two keynote speakers.

The research department is working on changeouts to replace the Taper artifacts in the Treasure's gallery.

Saturday, we hosted a program titled *Date with a Document* for teachers using primary sources.

The Ghost cue's current changeout is devoted to The Divine Nine sororities.

## **Director of Marketing and Guest Experience report**

Our visitation numbers continue to increase, with buses being 30% of our annual visits. The ALPLM has 173 groups booked through the end of the year.

The ALPLM welcomed 465 families with our *Museums for All* program.

Team Lincoln is coming up on its first year with 654 memberships sold.

## 1. Discussion & Vote on Outgoing Loan

Trustee Jessica Harris motioned to approve the loan in principle as requested. Trustee Melinda Spitzer-Johnston seconded the motion. The motion was unanimously approved.

# 2. <u>Discussion of Provisions of PA 102-955</u>
