Biographical Information/Overview of Interview: Charles Ross, born and raised in Waverly, Illinois, has been showing Montadale sheep for the past 25 years. In the past, he attended the shows with his son, but now, while his son is in the service and deployed to Iraq, Ross shows sheep with his granddaughter. Ross shows how they hand-trim the sheep's wool to prepare it for the show ring, and explains the difference in the wool between a sheep bred for wool and one bred for meat. He also explains what a judge looks for in good sheep.
