Abstract

Larry L. Bomke, Pension Crisis in Illinois, ISC-A-L-2016-006

Biographical Information Overview of Interview: Larry Bomke is the former Republican Senator of the fiftieth (50th) Senatorial District of the State of Illinois, serving in that position from 1995 to January of 2013. He was born in Springfield, Illinois in June, 1950 and grew up on a farm in the Springfield area. Prior to his appointment to the Illinois State Senate when Karen Hasara was elected as mayor of Springfield, Bomke had served nineteen and a half years on the Sangamon County Board. He attended high school in Springfield and graduated from Lincoln Land Community College. Professionally, Mr. Bomke is a partner in a Springfield area insurance company and lived in Springfield at the time of this interview. His wife is a retired school teacher and they have two children.

This interview highlights Senator Bomke's experience in the Illinois Senate when state employee pensions became a highly controversial issue. The evolution of the state pension crisis is discussed, with Bomke relating his, the legislatures' and past Governors' roles in repeated attempts to reform Illinois's pension system. He addresses how the Illinois General Assembly has increasingly been dominated by Democrats, and the impact that election cycles have had on discussions about pension reform. He discusses the effects of a law passed during the Edgar administration requiring the state to pay an ever increasing amount to the pension system (pension ramp), and of the law passed during the Blagojevich administration authorizing pension holidays. Bomke shares his thoughts about existing system conditions contributing to the problem, potential solutions and discusses his views on recent changes designed to address funding concerns.
