Abstract

Biographical Information Overview of Interview: Jarleth (Jan) Staggs was born on May 3, 1940 in Urbana, Illinois, and grew up in nearby Champaign. He graduated from high school in 1958, and attended the University of Illinois, earning a degree in economics in 1962. Jan married Francie Davidson later that year. He earned a Master's Degree in industrial relations in 1964, and took a job with the state of Illinois in Decatur. In March, 1966 he was drafted into the army, and attended basic training at Ft. Polk, Louisiana. Due to his level of education, was assigned a personnel MOS (military occupational specialty), and learned his duties on the job at Ft. Carson, Colorado. By November, 1966 Staggs was in Okinawa and was assigned to the headquarters unit. While in Okinawa, he processed assignment (levy) orders for enlisted personnel. Francie arrived in Okinawa a couple of months later, and the couple lived off base and traveled widely in the Far East. Their daughter Marcia Anne was born in January, 1968, shortly before Jan was shipped back to the states, completing his tour of duty.

The couple settled first in Moline, Illinois, where Jan returned to his state position. They moved several times over the next few years, settling in Springfield in 1973 when Jan took a job in Governor Dan Walker's budget office. In 1978 he became the Executive Director of the Illinois Occupational Information Coordinating Committee, a position that was mandated by federal legislation, and was also funded with federal dollars. He still held that position when he retired in 1999.
