Biographical Information Overview of Interview: Stephanie Marshall was born in the Bronx, New York in 1945. At the age of eight she moved to Long Island and graduated from East Meadow High School in 1963. She earned a BA from Queens College in New York City, an MA from the University of Chicago, and a PhD from Loyola University in Chicago. Stephanie began her career as an Elementary teacher for the Alsip (IL) School District. She later worked at the Naperville District #203 as a Curriculum Specialist and then on to Batavia eventually being the Superintendent of Schools. In 1986, she became the CEO/President of the newly created Illinois Math Science Academy in Aurora, Illinois. She served in this capacity until her retirement in 2007. She now serves as the President Emeritus at the Academy. Dr. Marshall has been the author of over 40 published journal articles and in 2006 published *The Power to Transform: Leadership That Brings Learning and Schooling to Life*. This book earned a 2007 Educators Award from the Kappa Gamma Society International. Stephanie was inducted into the Lincoln Academy of Illinois and in 2012 was appointed by the Governor to be a Trustee of the Lincoln Academy.

This interview details the development of the Illinois Math Science Academy in unsuccessful legislative efforts (1984) to its inclusion in the 1985 Educational Reform Act. Stephanie discusses the legislative parameters which created a residential facility in the Fox River Valley for students grades 10-12. She discusses the phased start of the school (one grade added each year for three years), the development of the curriculum, the selection process for students, the hiring of the staff, the organization of the residential halls, the unique schedule including intersession and off site research Wednesdays, the extra student activities, and the creation of a learning environment. Dr. Marshall also discusses the partnerships with business/industry, higher education, community colleges, and the schools throughout Illinois.
