Biographical information Overview of Interview: Bob Coomer was born April 7, 1945 in St. Louis, Missouri. Bob's family moved to rural Athens, Illinois where he graduated from high school in 1963. He started college in the fall of 1963 at Western Illinois University; however, he was drafted into the US Army during the Vietnam War. Bob returned to WIU in 1968 where he successfully completed his BA degree in Parks & Recreation Administration in 1971. Using G.I Bill benefits, he transferred to University of Illinois-Champaign, and received his MA degree in Parks and Recreation Administration in 1973. He began his career in Dayton, Ohio in 1973 with the Montgomery Parks and Recreation, then moved to Columbus, Indiana, where he worked with Parks and Recreation from 1975-1977. Bob and family moved to Illinois and sold insurance for one year, then returned to a career in Parks and Recreation. He started with the IL Department of Conservation in 1978, ultimately serving as assistant to the bureau chief until 1985.

In 1985, Governor James Thompson created the Illinois Historic Preservation Agency (IHPA). Bob was transferred over to the new Agency in the capacity of Superintendent of Historic Sites. He was responsible for the initial set up and oversight of the state's many historic sites. Bob worked directly with the newly created IHPA Board of Trustees and initial Director, Dr. David Kenny, to transfer the sites over to IHPA. He has served with all Agency Directors, including Dr. Kenny, Dr. Michael Devine, Susan Mogerman, and Maynard Crossland. In 2004 Coomer himself was named Agency Director. His duties included fiscal oversight; legislative work and Trustee liaison, plus restoration of the historic Journal Register building into IHPA offices, and the Abraham Lincoln Presidential Library and Museum project development and completion. He retired from the agency at the end of 2007.
