Abstract

Biographical Information Overview of Interview: Sheila Smith was born in Chicago, Illinois in 1945, and graduated from Woodlands Academy of the Sacred Heart in Lake Forest, Illinois. Sheila obtained a BA in political science from Barat College in 1970 and a MA in political science and public administration from the University of Illinois-Chicago (Circle campus) in 1971. Upon graduating, Sheila worked in investment banking. In 1984, she helped create a multi-million-dollar company, ARC Global Technologies Inc. In 1995, she served on the National Cooperative Bank and the NCB Development Corporation, which helped expand financing for cooperative businesses. From 2000 to 2012, Sheila served on the Board of Directors of Centers for New Horizons located in Chicago. As the chair and later chief executive office for the Barat College Board of Trustees in 2001, Sheila finalized a merger with DePaul University. In 2001 she became the president of Mount St. Clare College in Clinton, Iowa. At the time of the interview Smith served as the chair and CEO of the Barat Education Foundation, which works with teachers and students on American History, civics education and government courses. Other projects Sheila has been involved with include Kids Voting USA and Reading in Motion. Sheila also has run for political office including the US Congress and State Lt. Governor. Sheila is the President of Consult Ltd. Inc. a financial management consulting company serving small businesses, non-profits, and large public and private sector entities.

Sheila examines the role of the Barat Education Foundation and its work with teachers, school administrators, and students to promote civics education in Illinois through educational programs such as Our American Voice and Citizen U. In addition, Smith talks about the Foundation's relationship with the Library of Congress in promoting the use of primary sources through professional development and school curriculum projects. This includes the Primary Source Nexus website. She also discussed the support the Barat Education Foundation provides in a statewide semester high school-level civics course. Additional interview topics include media literacy, working with other non-profits on civics nngagement, 'Kids Voting,' Reading in Motion, and the extensive CPDU professional development opportunities for teachers.
