### **Abstract**

Paul Shuman, Oral History of IL Agriculture, AIS-V-L-2008-067

Biographical Information Overview of Interview: Paul Shuman was born on December 10th, 1937 in Decatur, Illinois and grew up on the Charles Shuman family farm in rural Sullivan, Illinois, which he described at some length. His father was Charles Shuman who served first as President of the Illinois Farm Bureau before becoming President of the American Farm Bureau from 1954 through 1971, where he served as a powerful and articulate advocate for the free market system in agriculture. Charles consistently advocated that the federal government dramatically reduce its involvement in the agricultural economy. In 1963, Charles successfully led farmers in defeating the Wheat Referendum, a government measure that sought to establish a two-price plan including acreage allotments and land retirements for individual farmers.

Paul followed in his father's footsteps both as a farmer and as a member of the Illinois Farm Bureau, where he served on the Board of Directors for many years. He discussed the many changes he observed in farming during his lifetime, including increased mechanization, the importance of genetics in both livestock and plants, the shift from natural fertilizers to chemicals, and the importance of management skills and marketing expertise for today's farmers. Paul also discussed the ongoing debate about Country of Origin labeling (tracking livestock through their lives), Counter-Cyclical Payments, Variable-Rate Technology; the Conservation Reserve Program and federal crop insurance.
