## **Abstract**

**Biographical Information Overview of Interview:** Robert Pinkerton is the past President of the Illinois Retired Teachers' Association (IRTA). Mr. Pinkerton was born in June, 1941 in Roodhouse, Illinois and currently lives in Jacksonville, Illinois. He grew up in Whitehall and spent his professional career in K-12 public education in the Whitehall, Roodhouse area of Illinois. He received his undergraduate degree from Southern Illinois University Edwardsville (SIUE), and graduate degrees from the University of Illinois Springfield (UIS). He spent thirty years as a teacher and Principal in the North Green Unit District # 3 at Whitehall/Roodhouse, Illinois. He retired from these positions in 1994 through the Teacher Retirement System's 5+5 Program. Mr. Pinkerton has had twenty-two years of active service in the Illinois Retired Teachers Association (IRTA). He served this organization as Region 14 Legislative Chair, State Legislative Chair, Area 4 representative, IRTA vice-President, IRTA President and current Past President.

This interview covers Mr. Pinkerton's professional career as a public school educator in Illinois, both as a teacher and administrator. These experiences reflect and represent the experiences of most public school educators in Illinois who are enrolled in the state's Teacher Retirement System. This interview also highlights Mr. Pinkerton's extensive experience through several important roles in the Illinois Retired Teacher Association that adds another perspective on the current conditions of the state's pension systems. His legislative positions with IRTA placed him in direct contact with the development of pension related legislation, in particular, Senate Bill 1 of 2013, an action that was eventually declared to be unconstitutional by the Illinois Supreme Court in 2015. Chicago is not a part of the IRTA.
