# Abstract

### John S. Raschke, Veterans Remember, VRV-A-L-2011-049

**Biographical Information Overview of Interview:** John S. Raschke was born on November 2nd, 1947 in Geneseo, Illinois, and grew up on the family farm outside of Geneseo. Upon graduation from high school in 1965, he worked at the local Farmall plant for a year, then enlisted in the Army in October, 1966. He attended Basic Training at Ft. Campbell, Kentucky in 1967, and during follow-on training as an Army medic, he decided to attend the Officer Candidate School, which he attended at Ft. Belvoir, Virginia. In 1968 he was commissioned in the Engineer branch, then attended an advisor training school at Ft. Bliss, Texas, where he also received training in the Vietnamese language. In between these schools, he married his high school sweetheart.

Raschke arrived in South Vietnam in July of 1969, and was assigned to the Military Assistance Command – Vietnam (MAC-V) and stationed in the village of Vi Thanh, Chuong Thien Province (in the Mekong Delta region) working with various South Vietnamese army units (ARVN) as an engineer and infantry advisor. During the interview he talked extensively about the nature of those duties, and about the patrols on which he frequently accompanied ARVN units while stationed there. Raschke lived on a small compound with other military advisors, both military and civilian, but spent much more time with South Vietnamese units, experiencing the war from their perspective, fighting an elusive Viet Cong enemy. After he returned home on emergency leave in June, 1970, near the end of his one year tour in Vietnam, he was reassigned to Ft. Leonard Wood Missouri. He was discharged one year latter, and attended Black Hawk using his G.I. Bill benefits.
