**Biographical Information Overview of Interview:** Phil Krone was born on March 1, 1941 in Chicago, Illinois. Growing up in Chicago, Phil was the son of very active liberal Democrats. He attended Lakeview High School, where he graduated in 1958. In 1959, Krone began his college education at Haverford College in Philadelphia, Pennsylvania. He transferred to Roosevelt University in Chicago where he graduated in 1962. It was also in 1962 that he began voting in Republican primaries. It was during his time at Roosevelt College that Krone met future Illinois Senator Chuck Percy and future Illinois Governor Dick Ogilvie. For several years after college he took several different teaching jobs in the Chicago area, including a position at Dunbar High School.

In 1969, Krone began a career as a political consultant which led to him travelling across the world, including an extended period of time being a consultant to the Chinese Ambassador in the United States. After only 12 years as a republican, Krone became a liberal Democrat in 1974. In 1977 he worked on the campaign staff for Senator Tom Hines during his election for president of the Illinois Senate. In 1980 Krone as a consultant for state Senator Richard M. Daley in Daley's campaign for the State's Attorney. In the late 1980s, he gained access to Hungary for a week by pretending to be the General Secretary of the Communist Party of Illinois. In all, Krone has been to Europe somewhere between 150 and 200 times for either business or personal reasons. Krone was diagnosed with gallbladder cancer in 2005, and he was later diagnosed with liver cancer. He passed away in August of 2010.
