## Abstract Dr. J.W. Smith, *Sports Stories -IHSA*, SIH-A-L-2017-083

Biographical Information Overview of Interview: J. W. Smith was born in Chicago, Illinois in July, 1937, and grew up in Chicago attending both vocational schools and Dunbar High School. While at Dunbar, Smith participated in both football and track. Upon graduating from Dunbar in 1955, he attended Chicago State University and then Northern Illinois University. While at NIU, he played on the school's football team, and saw action in the Mineral Bowl. The Huskies were named the number one college team in the nation in its division. Majoring in physical education, Smith returned to Chicago and taught and coached at three high schools, Harlan from 1963-1969, Kenwood from 1969-1974, and Julian from 1975-1989. J.W. coached football and track for each school. While at Julian, he coached very successful football teams which often competed in the Chicago Prep Bowl. This game, played at Soldier Field each year, was a major sporting event in Chicago prior to the establishment of the IHSA State Football Playoffs. Smith also coached many track athletes who won individual medals at the IHSA State Track Meet in Charleston. In 1989, Dr. Smith became the Chicago Public Schools (CPS) football coordinator. Then in 1995, he become the CPS Director of Sports Administration and served in that capacity until 2003. Dr. Smith earned his masters' degree from Indiana University in 1966 and a doctorate from the University of Illinois-Chicago in 1995.

This interview looks at Chicago Public League sports through the eyes of a former high school athlete (football and track) and successful football and track coach. The former sports administration director covered challenges facing CPS high schools, competition in the Prep Bowl, winning the Shield (an award for best team in that sport), creating a football program at a newly created high school, and developing underclass football programs. As the sports administrator director, he was involved in dividing the Chicago teams into various divisions based on geography and skill level, assigning schools to available stadiums, adding new high school sports, issues of residency/eligibility, and CPS's relations with the Illinois High School Association.
