## Abstract Bob Kustra, *Illinois Statecraft*, ISG-A-L-2011-006

**Biographical Information Overview of Interview:** Robert Walter Kustra was born to Walter and Loretto Kustra on March 21, 1943 in St. Louis, Missouri. After graduating from Laboure High School, Kustra attended Benedictine College in Atchison, Kansas. Inspired in part by John F. Kennedy's call to public service, Kustra earned his B.A. in political science in 1965 and then enrolled in a master of public administration program at Southern Illinois University. As part of this program he interned as the assistant city manager for Carbondale during a time of student unrest. Following graduation in 1967, he worked as an administrative assistant to Illinois Speakers Ralph Smith and Jack Walker. When W. Robert Blair became Speaker in 1971, Blair replaced Walker's staff with his own, forcing Kustra out of the legislature. Kustra worked as a criminal justice planner for Champaign and Vermilion Counties and returned to academia, completing his Ph.D. in political science at the University of Illinois in 1975.

Kustra was elected to the Glenview Village Board in 1978, the same year he began work as head of U.S. Senator Charles Percy's Chicago office staff. In 1980, Kustra won election to the Illinois House, representing the 4th District. He soon won recognition as the "Best Freshman Representative" by the *Illinois Political Reporter*. In 1982, he was elected to the Illinois Senate from the 29th District and remained in the Senate until his election as lieutenant governor in 1990. Although he announced his decision to leave the Edgar administration and join WLS radio in 1994, Kustra agreed to stay on, following Edgar's heart surgery in early July. As lieutenant governor, he shaped several important initiatives, including Project Success, Illinois River conservation, and higher education reform, and served as Edgar's senior adviser on economic development during the second term. Defeated in the 1996 Republican primary for U.S. Senate, Kustra served as lieutenant governor until he became president of Eastern Kentucky University in July 1998. He later served on numerous higher education boards and became president of Boise State University in 2003.
