# Abstract

## Edward (Pat) Stapleton, Veterans Remember, VR2-V-L-2008-011

**Biographical Information Overview of Interview:** Edward (Pat) Stapleton was born on August 16, 1921 in New Berlin, Illinois. At the age of eight the family house burned down, and the family moved to a farm in rural New Berlin. Pat discusses the many jobs his father took up during the great depression, including running the farm, work as a bar owner and running a dance hall, as well as running a small rodeo. Pat was attending a Bears game when he heard about Pearl Harbor and immediately tried to enlist, but was rejected for health reasons. He was finally able to enlist in September 1943, and received his basic infantry training at Camp McClellan, Alabama. He married Arlene Mae Thompson, his Illinois sweetheart, on December 3rd, 1943, just days before sailing to Italy.

Once there, he was assigned to Company I of the 143rd Infantry Regiment, 36th Infantry Division, a Texas National Guard unit that had already seen heavy combat in Italy. Pat first saw action at Anzio, participated in the liberation of Rome, then was shipped with the 36th Division to southern France, where he fought in the Vosges Mountain campaign before advancing into Germany proper. Pat recalled several brutal combat experiences, and the high casualty rates suffered by the unit during a long stretch of continuous combat. His also shared his vivid memories of liberating a German concentration camp in southern Germany. He served on occupation duty in Germany for several months, and arrived back home in December of 1945, just in time for Christmas. He passed away on January 31, 2012.

**Topics Covered:** Childhood memories of growing up in central Illinois during depression; Pearl Harbor; U.S. Army infantryman during WW II – Italian and southern Europe theaters; Company I of the 143rd Infantry Regiment, 36th Infantry Division; Rome – Arno campaign; Southern France campaign; Vosges Mountain campaign; Rhineland campaign; Dachau concentration camp liberation; reflection on German soldiers
