Abstract

Biographical Information Overview of Interview: George Fleischli was born on February 2, 1944 in Springfield, Illinois, and grew up in Springfield attending Cathedral Grade School and Griffin High School, both parochial schools. Following graduation, he attended Bradley University in Peoria, Illinois, where he majored in Education and English and played football until a knee injury sidelined him. Upon graduation, he taught in Peoria for a year and then moved back to Springfield, where he taught English and coached football at Griffin High School. During this time, he made an unsuccessful run for Springfield Street Commissioner. In 1979, he went to work for the Department of Conservation as the Assistant Director of the Young Adult Conservation Corps.

When Jim Edgar was appointed by Governor Thompson to be Secretary of State, Fleischli was selected as the Director of Physical Services, where he was responsible for all of the Secretary of State buildings and grounds, including the Capitol Complex in Springfield. During the next several years, Fleischli oversaw the renovation of both the interior and exterior of the Capitol building, as well as numerous other projects. It was also during his tenure that the Capitol building was the scene of a protracted struggle between proand anti-Equal Rights Amendment forces. In 1991, Fleischli joined newly elected Governor Edgar in his administration. For the next four years, he served as an Executive Assistant, with oversight over the Capitol Development Board, the Department of Agriculture, the Department of Conservation, the Department of Transportation, the Illinois Toll Authority, and the Illinois Racing Board. He played a significant role in the administration during the Great Flood of 1993, in the acquisition of Site M (Jim Edgar Panther Creek), and in the creation of the Department of Natural Resources. He retired from public service in 1995.
