Biographical Information Overview of Interview: Gail Huster was born in Chicago, Illinois in November, 1959 and grew up in Wheeling, Illinois. While at Wheeling High School, Gail competed in tennis, track, basketball, and the new sport of cross country. She also managed the volleyball team at a time when Title IX legislation expanded sports opportunities for girls. She graduated in 1977 then went to Western Illinois University in Macomb, earning a BS in Physical Education in 1981. While at Western, she competed on the school's cross country and track teams.

After college, Gail returned to Wheeling as an instructional aide, while also coaching volleyball, basketball and track from 1982 to 1987. Huster then worked at Elmhurst York High School from 1987 to 1992, where she coached track. After a twelve year hiatus from teaching, Gail returned to teaching and coaching at Hinsdale South High School in 2005, teaching driver education and physical education-health. She also returned to coaching track.

Gail met her husband Tom while he officiated one of her games. Tom encouraged her interest in officiating girls' basketball. Both Gail and Tom received the IHSA Basketball Officials of the Year award in 2015. Gail is also president of the local officials association, which helps with professional training of basketball officials. She discusses working state tournaments and gives insights into the skills a good sports official needs, including a thorough knowledge of the rules. She also talks about licensing, travel and expenses and evolving coaching strategies.
