Biographical Information Overview of Interview: Julie Ann Dirksen was born in Springfield, Illinois on January 27, 1942. She was the daughter of a first generation Italian American father, James Bucari and her mother Doris Payne. After graduating from Lanphier High School in 1960, she attended Western Illinois University for two years. She transferred to Southern Illinois University-Carbondale and graduated in 1964 with an education degree. After teaching at the elementary level for 6 years she became the Director of Community Services for Memorial Medical Center in Springfield, Illinois. After serving in that position for 25 years, she then became the first Director of Guest Services at the Abraham Lincoln Presidential Library and Museum, a part of the Illinois Historical Preservation Agency. In addition to her employment, Julie has served almost continuously as a volunteer in the Springfield community. This has included organizing the first "Festival of Trees" at Memorial Medical Center, head of the Springfield International Visitors Organization, part of Springfield groups seeking to bring the Abraham Lincoln Presidential Library and Museum to Springfield, and a member of the Illinois and Springfield Bicentennial Commissions.

This interview includes discussion of Julie's volunteering at Memorial Hospital and then accepting a position there. It includes discussion of her role at Memorial Hospital in continuing and expanding their volunteer support and educational outreach. Julie reviews her participation in numerous civic groups and in particular relates discussions involving Senator Dick Durbin and IHPA Board of Director member Julie Cellini about establishing the Abraham Lincoln Library and Museum in Springfield. She details her approach to the job of Director of Guest Services for the ALPLM. There is extensive discussion of the preparation in the Springfield community for the formal dedication and opening of the ALPLM, especially her activities in a state/community group called "Company is Coming". Julie reviews the process of establishing the volunteer support for ALPLM and the budgeting and planning process. Finally she reviews her retirement and work with the state and local Bicentennial commissions.
