**Biographical Information Overview of Interview:** Robert (Bob) Mitchler was born on June 4th, 1920 in Aurora (Kane County), Illinois. He grew up during the depression and World War II, with his Austrian immigrant father instilling in him the values of hard work and being a friend to all. Mitchler graduated from high school in 1937. He served in the U.S. Navy as a petty officer and stenographer during both World War II and the Korean War. (See Mitchler's interview on his wartime experiences in the ALPL *Veterans Remember* project.) Upon his resignation from the Navy in 1952, he returned to college, and to his new wife, Helen (Drew) Mitchler.

Mitchler tried his hand at several positions before being hired by the Northern Illinois Gas Company. He also became active in numerous organizations, including the Young Republicans in Kane County. In 1964 he ran for the Illinois State Senate and won. He held that office until being defeated in the Republican primary in 1980, having elected to not campaign vigorously that year. During his long tenure in the Senate, Mitchler saw the legislature evolve from a body of citizen legislators that met for several months every other year, to a group of professional legislators meeting yearly. Throughout his years in the legislature he consistently fought for smaller government and lower taxes, championed veterans concerns, worked on important clean water legislation, and in 1970 voted against the imposition of a state income tax and against the state's new Constitution due to its position on taking bonding decisions away from the citizens of the state. Mitchler voted several times against the Equal Rights Amendment, which came up for a vote every year from 1972 through 1982. Following his legislative career, he spent several years as a legislative liaison officer for the Department of Veterans Affairs.
