Abstract

Biographical Information/Overview of Interview: Oluwatamilore Odimayo was born in Lagos, Nigeria. He attended boarding school for six years, graduating high school when he was sixteen years old. After his high school graduation, he moved with his family to Orlando, Florida, where he began attending Florida International University. From a young age Odimayo knew he wanted to help people work through their trauma in a clinical capacity. When he began at Florida International University, he was a pre-med student, intending to eventually become a psychiatrist. He found his passion in psychology, however, and soon switched his major upon receiving his father's blessing. He graduated and later earned his masters in counseling at the University of Illinois Springfield.

Upon his graduation from UIS, he worked for a variety of counseling offices to earn his license, including inpatient, outpatient, and rehabilitation. In 2020, he was working for a rehabilitation center. When the Illinois stay-at-home order went into effect in March 2020, he saw the immediate impact on the progress of the individuals he served at the rehabilitation center. He eventually left that job and focused on his private practice at Killian and Associates Mental Health Group in Springfield, Illinois. There he was able to experience much greater flexibility. However, the pandemic continued to have an impact on his experiences as a counselor. Throughout his interview he discusses the impact the COVID-19 pandemic had on his patients' mental health as well as his own.
