Abstract

Biographical Information Overview of Interview: This interview with Governor Jim Edgar and Brenda Edgar is a continuation of the Governor Edgar oral history project, and addresses their life together, both personally, and especially as it was lived in the public eye. The interview starts with their meeting while both were students at Eastern Illinois University (Charleston) in June of 1966. The interview covers their courtship and marriage, Brenda's help with Jim's campaign for class president at Eastern, his early experiences as an intern with the Illinois legislature, and his decision to run for the legislature in 1974. He lost that year, but was successful in 1976. Mrs. Edgar talks about her thoughts early on about his political career, and about her own involvement with her husband's many political campaigns. Governor Edgar talked about three key phone calls from Governor Thompson: a call in 1979 to become Thompson's legislative liaison, a call in 1980 offering Edgar the Secretary of State position, and finally a call in 1979 where Thompson told Edgar of his decision not to run for reelection, giving Edgar the opportunity to run for Governor in 1990. Finally, the two discussed Governor Edgar's decision not to run for reelection in 1978, and Mrs. Edgar addressed the challenges of serving as Illinois's First Lady.
