Abstract

Biographical Information/Overview of Interview: Brian Brady was born in Chicago, Illinois in 1966. He attended Evanston public schools, graduating from Evanston High School in 1985. While in high school, Brian was active in sports, including football, basketball and baseball, as well as debate. He then attended Friends World College, Evergreen, Truman State, and National Louis University. Each provided unique civics engagement opportunities. In 1992, Brian earned a BA from National Louis University. He later earned a degree at DePaul University. Brian's work experiences include Lotus Development, Acorn, and the Mikva Challenge beginning in 1998. At the time of this interview he was president for Mikva Challenge, a non-profit organization which was begun by Judge Abner Mikva and his wife Zoe.

In this interview, Brady looks at how a non-profit civics organization which began in 1998 can now be found in twelve sites, including Washington D.C and southern California. Started by Judge Abner Mikva and his wife Zoe, the Mikva Challenge was formed on the concept of creating democratic opportunities for youth living in under-resourced neighborhoods. The Mikva Challenge cultivates students' interests through in-school services to middle and high schools, community action plans on local issues, city wide youth councils, action civics events, and through elections in action (a favorite for Judge Mikva). The organization was an active participant in the Illinois Coalition on Civics, the Civics Legislative Task Force, and the professional development for Civics Teachers. This interview highlights examples of student civics participation in each of the above areas. See also the extensive interview with Judge Mikva about his many years in state-level and national politics.
