## Abstract Neil Hartigan, Illinois Statecraft, ISG-A-L-2010-012

**Biographical Information Overview of Interview:** Neil Hartigan was born on May 4th, 1938 in Chicago and grew up in an Irish Catholic family, the son of a lawyer who was also an alderman from the Rogers Park neighborhood. Hartigan attended Catholic Schools through high school and attended Georgetown University in Washington, D.C., before returning to Chicago to attend the Loyola University Law School, graduating in 1962. He soon began working for the City of Chicago and became an administrative assistant to Mayor Richard J. Daley. He continued with the city in a variety of positions, until the party selected him to be a candidate for lieutenant governor for the 1972 gubernatorial campaign. Hartigan won the Democratic primary, even while the party's candidate, Paul Simon, was defeated by the outsider Dan Walker, running on a campaign that condemned the Daley political machine. Dan Walker went on to win the general election, as did Hartigan, but there were serious tensions between Lieutenant Governor Hartigan and Governor Walker from the start. Due to that, Hartigan was unable to play any meaningful role in the Walker administration. He ran as the lieutenant governor candidate with Michael Howlett in 1976, but Howlett was soundly defeated by Jim Thompson in the general election.

In 1982 Hartigan ran for attorney general, defeating the incumbent Republican, Tyrone Fahner, in the general election. He served as Illinois's attorney general for two terms, and in 1990 he ran for governor against Jim Edgar, who had served for ten years as secretary of state. Attorney General Hartigan ran a spirited campaign, but lost to Edgar by a razor thin margin. Mr. Hartigan was unable to continue with the interview, so his story does not include his years as Attorney General or his race against Edgar for governor in 1990.
