## Abstract

#### Dr. Richard Wagner, Education is Key-Community College, EC-A-L-2013-100

**Biographical Information Overview of Interview:** Dr. Richard (Dick) Wagner was born in Eureka, Illinois in 1938. He graduated from Chenoa High School in 1956, and earned a bachelor of arts degree from Bradley University in 1960 and a MA and Ph.D. from the University of Pittsburg (1961 and 1967). In 1969 he joined the staff of the Illinois Board of Higher Education, where he served in a variety of capacities, including as deputy director of the Fiscal Department, and then its director. In 1980 he became the executive director of the Board of Higher Education until his retirement in 1998. As Executive Director, he worked on higher education programs, fiscal accountability, performance, articulations, building programs, and policy issues for four year institutions (public/private) and two year community colleges.

Dr. Wagner covers the growth of Illinois's community college movement from 1965-1998 and its relationship to the overall 'Higher Education Plan for Illinois.'
