Biographical Information Overview of Interview: SPC (Specialist) Sasha M. (Briggs) Phillips was born in Macomb, Illinois on September 20th, 1987, and graduated from high school in 2006. She was in 8th Grade when the 9/11 Attacks occurred and enlisted in the Illinois National Guard at age seventeen. She completed Advanced Individual Training at Ft. Eustis, Virginia, and began duty with B. Company, 2-238th Aviation in 2008 as a 15F (Aircraft Electrician) servicing CH-47 Chinook helicopters. Deployed to Afghanistan in January 2009, she served nine months altogether, with time spent in Kandahar, at Forward Operating Base Shank, and at Bagram Air Base from March to November of that year. Under mortar fire while serving in a combat zone, she was awarded the Combat Action Badge. Her future husband, whom she met during her Advanced Individual Training (AIT) at Ft. Eustis, Virginia, was deployed to Iraq while she served in Afghanistan. The two were married after Marcus's return in October, 2010.
