## Abstract Thomas Martin, *Agriculture in Illinois*, AI-A-L-2018-006

**Biographical Information/Overview of Interview:** Thomas Martin was born in 1956 and grew up on the family farm two miles south of Mt. Pulaski, Illinois. Tom is the 6th generation to live on the farm, with his first ancestors arriving in Illinois in 1826. After graduating from high school, he attended the University of Illinois and graduated from Southern Illinois University in Carbondale with a degree in Biology. After several years away from farming, Tom returned to the farm and was an early adopter of no-till farming and planting earlier in the season, a change from cultural practices which were designed to improve soil structure and achieve sustainably high yields.

Martin has been very active in his community as a member of the Mt. Pulaski Economic Development Board, the Mt. Pulaski Courthouse Foundation, the Agriculture Leadership Program and the development of the Lincoln Heritage Area. Other subjects discussed include changes in rural communities, the impact of local landownership verses investment ownership, changes in the landlord tenant relationship and windfarm issues. Tom was named one of three Illinois Master Farmers in 2017 by the *Illinois Times*. Tom is married and has two grown children.
