## **Abstract**

Carol Murray, Women's Basketball in IL, DGB-V-D-2004-010

**Biographical Information Overview of Interview:** Carol Murray was born on (date) in (place). She graduated from Poplar Bluff High School in Poplar Bluff, Missouri in 1965. Murray took part in play days during high school in which she participated in archery and basketball. After high school, Murray earned her bachelor's degree in physical education and history from Baylor University. Murray began coaching and teaching at Centralia High School during the 1970-71 school year. She was in charge of the Girls' Athletic Association during her first year there. Her team made it to the first state girls' basketball tournament in Illinois in 1977. Murray had a very successful coaching career at Centralia where she stayed for thirty-three years.
