# Abstract

**Biographical Information Overview of Interview:** Travis Wilson was born in Danville, Illinois in 1958. He Graduated from Westville High School in 1976. He earned a Bachelor's Degree from Illinois College in business administration and physical education in 1981. He earned a Masters from Western Illinois University and a Certificate of Advanced Study (CAS) from Eastern Illinois University. Travis began his work career with the Zeigler Coal Company. Later he came to Arthur, Illinois to serve as the principal and athletic director; he later became Superintendent. This interview reviews the referendum that led to the annexation first of Lovington in 2011 and Atwood-Hammond in 2013. Included are the strategies used for the referendum and for bringing the school districts together after the referendum.
