## Abstract Gene Reineke, *Illinois Statecraft*, ISG-A-L-2009-038

**Biographical Information Overview of Interview:** Eugene "Gene" Reineke was born on September 8th, 1956 in the borough of Queens, New York City, and grew up on Long Island until the family moved to St. Charles, Illinois when he was sixteen. From an early age, Gene had a fascination with politics, and majored in political science while in college at Loyola University in Chicago. In 1979 he began graduate school at Boston College, and thereafter served as an intern in the U.S. Congress before returning to Illinois to begin his working career. By 1983 he began working as a scheduler for Governor Jim Thompson, and soon was moving up the ladder, first as Thompson's director of Public Affairs in 1985, then director of Thompson's ambitious Build Illinois in 1986, then as the Director of Personnel from 1987-1988. He spent the last two years of Thompson's administration as the director of the Illinois Department of Central Management Services.

Reineke made the transition to the Jim Edgar administration, starting as the executive director of the Republican Party's State Central Committee. In 1992 he became the executive director of "Illinois for Bush – Quayle", and in 1993-1994 worked as the governor's executive assistant for Economic Development. Upon Edgar's reelection in 1994, Reineke took over as Chief of Staff, a position he held until his move to the private sector in early 1998. As Chief of Staff, he was actively involved in the governor's efforts to create the new Department of Natural Resources and the Department of Human Services, and with Edgar's concerted efforts for educational reform, plus countless other issues and concerns.
