Abstract

Biographical Information Overview of Interview: Mark Boozell was born on March 4, 1955 in Mason City, Iowa, but spent most of his early years in Loves Park, Illinois. Following high school, he attended Augustana College in Rock Island, Illinois, and graduated in 1977. He immediately set off for Washington, D.C., in search of a staff position in a congressional office, but when this turned up nothing, he applied for an opening in the Illinois House of Representatives Republican Caucus, and was hired by George Ryan, then minority leader. In 1980, he moved to the Department of Transportation, where he worked as a legislative liaison.

In 1983, Boozell became the legislative director for Secretary of State Jim Edgar, a position he held until he followed newly elected Governor Edgar, where he served as Edgar's assistant legislative liaison. Boozell took over the post as Director of Legislative Affairs in 1992, during a time when the administration was still struggling to balance the budget. Boozell served as Director of the Illinois Department of Insurance, and he also assisted Edgar's educational initiatives with the state legislature in 1997. Boozell returned to work directly for Edgar in 1998 as his Chief of Staff. Much of his work during the last year of the Edgar administration was spent on preparing for a smooth transition.

Following Boozell's many years with Edgar, he worked for Aon, a company based in Chicago. At the time of the interview he worked for the Dykema Law Firm.
