Biographical Information Overview of Interview: Richard Schachtsiek was born on August 22nd, 1951, and grew up in Quincy Illinois. After graduating in 1969 from Petersburg's Porta High School, he attended Western Illinois University. He graduated from Western Illinois University in 1973 with a B.A in Education. In 1975 he accepted a job with the Illinois Department of Conservation as a site interpreter at New Salem. After serving approximately two years there, he became the site manager at the Bryant Cottage State Historic Site. From Bryant Cottage, Richard, returned school to obtain his M.A. in small museum administration from Eastern Illinois University, graduating in 1979. In 1982 Richard accepted a position as a site interpreter at Lincoln's Tomb in Springfield, Illinois. From there he became the site administrator at the Postville and Mt. Pulaski Court Houses state historic site. He remained in this position until 2002 when he retired.

This interview reviewed Schachtsiek's career with the Illinois Historic Preservation Agency from 1975, when it was still a part of the Department of Conservation, until 2002 when he retired. He discusses the state historic sites of Bryant Cottage, New Salem, Lincoln's Tomb, and the Postville and Mt. Pulaski courthouses, addressing the historic significance of each. He discusses the change from being a division within the Conservation Department to being part of the new Historic Preservation Agency. He reflected on the differences that occurred during good and difficult financial times. He discussed the important role of local people and volunteers, especially as budgets grew tighter. Mr. Schachtsiek also addressed his relationships with local authorities and groups, other site administrators, and the administration in Springfield. Included is a discussion of the effect of the beginnings of the Abraham Presidential Library and Museum on local historic sites.

Topics Covered: General review of the career of an historic site interpreter, and site administrator for IHPA; Mid 1970s New Salem; IL Conservation Department and state historic sites; Bryant Cottage; Piatt County Historic Society; Eastern Illinois University small museum administrator program; Lincoln's Tomb; Logan County Tourism Bureau; Postville Courthouse; Mt. Pulaski Courthouse; Interactions with the IHPA; Robert Coomer; focusing on the career of Abraham Lincoln; working with local officials, volunteers, and tourism groups; impact of budget cuts on site management
