Abstract

Biographical Information Overview of Interview: Wesley (Wes) Duiker was born in February, 1924 in Orange City, Iowa, and grew up in small towns in Iowa, and later in upstate New York. Wes was the son of an American Reformed Church minister, and following his graduation from high school in 1941 he attended Hope College in Holland, Michigan with the intent of becoming a minister. In November, 1942 he quit school and enlisted in the U. S. Army Air Force.

Duiker began his military training in Fresno, California, then for the next two years progressed through a series of flight training courses at various posts. By the end of his training he received his wings as a B-26 Marauder pilot, a twin engine bomber. In late 1944 he received orders to Europe, and he and crew members flew a B-26 to France, but over a route that took them to Brazil, then across the Atlantic Ocean to Africa before heading north to Europe. Duiker flew his first mission from a base near Dijon, France on April 10th, 1945, and by early May and the end of the war he had logged eleven more missions. For the next year Duiker served in the occupation army at a variety of different locations, including Belgium and Germany. He spoke at length about this experience, and his extensive travels throughout Europe. His most memorable experiences included seeing the Dachau Concentration Camps, and observing one day of the Nuremburg War Crimes trial while General Alfred Jodl was being tried. He returned to the United States in June, 1946.
