Biographical Information Overview of Interview: Clarence Senor was born to Alphonso and Elizabeth Senor on November 17th, 1929 in Springfield, Illinois He grew up during the Great Depression and came of age during World War II. Clarence's mother found work during World War II at an ammunition plant in Illiopolis, Illinois, while he attended Feitshans High School in Springfield. Clarence dropped out of school in 1948 and worked at the Pillsbury Mills in Springfield until he enlisted in the Navy in January, 1951. He took his basic training at Great Lakes Naval Training Center, and was thereafter shipped to Japan. He was soon assigned to the U.S.S. Leonard F. Mason, a destroyer. The U.S.S. Mason saw service in the Sea of Japan off the eastern coast of Korea, cruising in Wonsan Harbor (North Korea) in support of an Aircraft Carrier task force. The ship was damaged in an accident and sailed to the west coast for repairs.

As an African American, Senor was part of the first wave of blacks to serve in a recently integrated military. He discusses those experiences, both good and bad, as well as the nature of his duties on board ship. He was seriously injured in a jeep accident in Hawaii (head injury and concussion), and was medically discharged in September of 1952. He returned to Springfield, and eventually found work on the city's fire department.
