**Biographical Information Overview of Interview:** Randall (Randy) Witter was born in November 1948 in Moline, Illinois. Randy grew up in Rock Island and graduated from high school in 1966. He graduated from Western Illinois University in 1970, and after being drafted into the U.S. Army, he served in Germany, then returned and attended graduate school at Sangamon State University, earning his master's in public administration in 1973. A few months later, in 1974, he began working with Bob Cook as a lobbyist in the Illinois state legislature, retiring in 2011.

In a previous interview in 2020 Randy included a discussion his personal memories about the ERA during his time as a lobbyist. In this interview, he discussed at length the legislative process as it occurs in Illinois. After laying out the basics of the process, he discussed the specific actions the legislature took during the 1972 through 1975 legislative sessions. Specifically, he explained what was written in a document prepared by the Legislative Research Unit for the year by year Equal Rights Amendment actions taken in the Illinois legislature.
