Abstract

Biographical Information/Overview of Interview: Gary McCants was born on July 22,1948 in Cincinnati, Ohio, where he grew up, graduating from Courter Technical High School in 1967. McCants earned a BS degree from Central State University (Wilberforce, Ohio) in 1971, and an MBA degree from Atlanta University in 1973. By 1975 he was newly married to Galda Garnett and began working with the Illinois House Democrats, living in Springfield. He spent the next fifteen years in Springfield working on the House Democratic staff.

Gary's spiritual awakening occurred in 1979 when he had a vivid dream and because of that came to believe that God had a purpose for him. For the next several years Gary struggled with what that might be, reluctant to believe that God's intent might lead him to the ministry and preaching. All the while, he continued to work in the Illinois House of Representatives. By the early months of 1981 McCants accepted that he was called to preach and began a lengthy period of training and reflections, which included taking courses under the auspices of the Illinois Conference, AME Church, Ministerial Training Board; Midwest Bible College in Bloomington, Illinois and National Baptist Training Institute satellite ministry, taught in Springfield, Illinois. This led to Gary accepting a call to minister to a small AME congregation, Bethel AME Church in Kewanee, Illinois in 1985, where he continued to serve until 1994. In that year he became pastor of Allen Chapel AME Church in Alton, IL.

In 1988 Gary resigned from the House Democratic staff, but soon began working as a staff analyst and later as lobbyist for the Illinois Banker's Association. He continued in that role until his retirement in 2012. He discussed his lobbying experiences during the heady real estate boom of the late 1990s and early 2000s, and also the housing market collapse which began in late 2008. McCants talked extensively about his memories of state Senator Barack Obama, and also about many of the other legislators he came to know during his thirty-five years with the legislature. In 2007 he was appointed as the presiding elder for the South District – Illinois Conference of the AME Church. Gary's wife Galda also became a reverend with the AME Church in 2009.
