Abstract

Biographical Information Overview of Interview: Thomas (Tom) Bowman was born on May 9th, 1947 in Springfield, Illinois, and grew up on the north side of Springfield in a large Catholic family. He attended parochial grade school and Griffin High School (also a Catholic school), graduating in 1967. In May, 1968 he awaiting acceptance into Southern Illinois University with the hope of becoming a pilot when he was drafted. Bowman attended Basic Training at Ft. Leonard Wood, Missouri, and Advanced Individual Training at Ft. Sam Houston, Texas, where he received training as a Medical Records Specialist. He arrived in South Vietnam in December, 1968.

Specialist Bowman was assigned to the 44th Medical Brigade, which was based at Nha Trang. While performing his duties as a Medical Records Specialist, he also performed a variety of other tasks, including assisting in triage, as an ambulance driver, accompanying teams going to the field on MEDCAPs (Medical Civil Action Program), and escorting psychiatric patients. He spent time in several locations, including the 6th Convalescent Hospital in Cam Ranh Bay, Nha Trang, and Saigon. Bowman discusses a sapper attack on the hospital at Cam Ranh Bay in August, 1969. He describes his R & R experiences at Vung Tau, South Vietnam, and in Bangkok, Thailand. He rotated home in December, 1969, and was immediately released from Active Service. He soon was attending classes at Sangamon State University in Springfield, Illinois, began working in law enforcement, and by 1973 had also joined the Illinois Air National Guard.
