Abstract

Biographical Information Overview of Interview: Paul Wisovaty was born on September 7, 1946 in Taylorville, Illinois. He was spending much of his time hanging out in pool halls in Taylorville, Illinois when he was drafted into the military in 1966. He spent eight weeks of basic training, followed by training as a radio telephone operator (RTO). He was then stationed at Fort Hood, Texas where he was assigned to work in a unit motor pool, change flat tires and other menial tests. He requested to be sent to Vietnam and arrived in country on December 30, 1967. He was assigned to the 3rd Squadron, 5th US Cavalry Regiment, 9th Infantry Division, which was stationed in the I Corps area of South Vietnam, close to North Vietnam. He discusses how the focus of the soldiers was to protect the man next to him, rather than to free the Vietnamese people. Instead of re-enlisting, he went back to the United States on June 2, 1968, where he was admitted to the University of Illinois. While there, he learned more about the Vietnam War and participated in anti-war protests. He graduated in 1973 with a degree in history and political science. In 1979, Wisovaty worked as a probation officer in Champaign County and then in Douglas County. He later joined Vietnam Veterans Against the War. He now talks to high school students about the Vietnam War and raises money for scholarships for veteran's children as a member of the Polish Legion for American Veterans. Being a veteran is still an integral part of his life. He discusses how his experience has changed his outlook on the world. Paul lived in Tuscola, Illinois at the time of the interview.
