**Biographical Information Overview of Interview**: Retta Keithley was born at the Dixon, Illinois Hospital and attended grade school and part of high school in Dixon. She recalls an instance where she saw Ronald "Dutch" Reagan performing in a play at the North Side Grade School, around the late 1920s. She is four years younger than Ronald Reagan so she did not know him personally. Retta also recalls a memory of Reagan walking his girlfriend, Margaret Cleaver, home, while all of the grade school kids were heckling him. Retta passed away on March 25, 2016 in Dixon, Illinois.
