**Biographical Information Overview of Interview:** David Gilbert was born in June, 1940 in Peru, Indiana. He grew up in a religious family that moved frequently. He attended Grace College in Winona Lake, Indiana, majoring in history; following graduation in 1963, he pursued graduate studies in journalism at Indiana University before landing a job with City News Bureau in Chicago. He also served in the Indiana National Guard during this time. By the late 1960s Gilbert was working for the Chicago Tribune, and was the Transportation Editor when candidate Jim Thompson asked him to become his press secretary in 1975. Gilbert was the first person hired to join Thompson's initial campaign for Governor.

Gilbert continued to serve as Thompson's press secretary for the next ten years, which included three political campaigns. Thompson won by a wide margin in 1976, beating Michael Howlett, Richard J. Daley's hand-picked candidate. In 1978 he won by the largest margin any governor was re-elected by, beating the State Comptroller, Michael Bakalis. In 1982, Thompson defeated Adlai Stevenson III by less than 5,000 votes, the closest election in Illinois history. Stevenson contested the election, and the Illinois Supreme Court finally decided the race in Thompson's favor only three days from the inauguration. U.S. Attorney Daniel Webb subsequently aggressively pursued allegations of vote fraud, a case that eventually resulted in sixty-three convictions after the discovery of approximately 100,000 votes. Gilbert discussed all of this in detail, recounting many stories of Thompson's special skills as a politician and Illinois's chief executive.
