Abstract

Biographical Information Overview of Interview: Jennifer Hamilton was born in Clinton, Iowa in 1966. She graduated from Fulton High School in 1984. Jennifer attended Mount Saint Clare College in Clinton Iowa for a year before transferring to Northwestern College in Orange City, Iowa. She graduated with a major in psychology. Her first job after college was at Lutheran Social Services of Iowa. She then moved to the Bloomington-Normal area where she spent the next twenty-two years. She earned a BS from Illinois State University in language arts and the social sciences and an MS degree in counseling, also from Illinois State. Jennifer worked at Heartland Community College in a variety of positions (education consultant, academic athletic advisor, and adjunct instructor) and at Gridley School District #16 as a counselor. She then worked at Bloomington School District #87 and Normal Community SD #5, including a position as the associate principal. During these assignments Jennifer earned her general administrative and superintendent certificates from Illinois State. In 2015, she became superintendent/principal in Damiansville School District # 62, a small prek-8 school east of St. Louis. In 2016, she became superintendent for the dual districts located in Ohio, Illinois (#17 and #505) located in northern Illinois.

Superintendent Hamilton discusses the very small dual districts located in Ohio, Illinois. The K-8 school has around eighty students; while the high school has between thirty-forty students. Supported by wind farms to meet financial needs, Hamilton looks at how the board of education and administration provide quality education for its students through athletic cooperatives, academic cooperatives, in house curriculum and grade structure, and through the local community college. She also reviews the challenges facing such small districts as well as the importance of the schools to the village of Ohio, to the community, and to the parents. Finally, Hamilton reviews past efforts to reorganize the district.
