Abstract

Biographical Information Overview of Interview: Matt Shipley was born in Clarendon Hills, Illinois in 1982. He moved early in his life from the south suburbs to Naperville. He graduated from Naperville Central in 2000, then earned his BA degree in 2003 and MA degree in 2004, majoring in accounting at the University of Illinois. Matt worked for financial firms for twelve years prior to coming to Indian Prairie School District #204. He was involved in school audits, bond schedules, and financial reports. Matt served as the comptroller of Indian Prairie School District #204 at the time of the interview. Matt has been responsible for developing a Site Based Reporting Initiative tied to the Every Student Succeeds Act, which replaced the No Child Left Behind Act. This has resulted in his participation in local, state, and national conferences. He was also involved in the many accounting changes required for the new Evidence Based School Funding model.

Shipley looks at a western suburban school district and how school funding has impacted district operations. He also talks about the growth of the district in the 1990s, the financial challenges during the state economic downturn, and its financial status in 2019 under the new Evidence Based School Funding Model. He also discusses the district's sources of revenue (mainly property tax-residential) and the growing population of English Language Learners (ELL) population. Shipley explains the site-based reporting required under the Every Student Succeeds Act (ESSA) in depth, as well as challenges in for future funding and expenditures due to mandates, salary increases, teacher shortages, pensions, and building upkeep. Shipley also highlighted the audit process and the Medicaid sources of federal revenue.
