Biographical Information Overview of Interview: Erin Isabel Bishop was born in Dixon Illinois on March 9, 1968. She grew up in Springfield Illinois, graduating from Sacred heart Academy in 1986. She graduated from Carroll College in Helena, Montana with a double major in history and French in 1990. After serving with the Lincoln Legal Papers from 1990-1993, Erin traveled to Ireland where she earned her MA in History in 1994 and her Ph.D. in History in 1997. Her Ph.D. dissertation resulted in the publication of two books, including *My Darling Danny*. Returning to Springfield, she accepted a Historical Research position with the Illinois Historic Preservation Agency Sites Division in 1997, and later accepted a position as the head of the newly created Abraham Lincoln Presidential Library and Museum Education Division in 2005. In August 2009 she resigned her position with the ALPLM to relocate with her family in a different city.

Erin discusses her early duties with the Lincoln Legal Papers, including extensive research in court houses throughout Illinois attempting to locate and copy legal papers involving the cases of Abraham Lincoln. A portion of the interview details Erin's time in Ireland where she developed an interest in women's history, which in turn led to an intensive interest in Mary O'Connell, the wife of Daniel O'Connell, a famous Irishman described as the "liberator". Erin describes in detail her work with many early sites in southern Illinois, including the Jerome Mansion and the Menard home. She also describes her work with the Lewis and Clark historic site, especially the bicentennial event. The final part of the interview details her work as the head of the ALPLM Education Division. She experienced setting up of programs under intense time pressure, and her approach to dealing with the thousands of students visiting the museum. Of special interest is her development of specific programs such as the traveling Abraham Lincoln Exhibit, Traveling Trunks, Horace Mann Teacher Institute, and the Summer Scholarship Program, resulting in an exhibit on the Springfield race riots. Finally, Erin gives an overview of dealing with both gender and politics in her position.
