Abstract

Ray Torry, Women's Basketball in IL, DGB-V-D-2004-015

Biographical Information Overview of Interview: Ray Torry was born on September 5, 1933 in Williamson, Illinois. He graduated from Livingston Community High School in Livingston, Illinois in 1951. During high school, Torry participated in baseball and basketball. His talents in baseball allowed him to play four years of competitive baseball for Illinois State University where he earned his bachelor's degree in health and physical education. Torry also earned his master's degree in educational administration.

In the fall of 1955, Torry began teaching and coaching at Leroy High School in Leroy, Illinois. He was the head coach and assistant coach for several sports, including football, basketball, and baseball. He spent two years away from Leroy when he was drafted into the Army. However, after his military tour, Torry returned to Leroy where he stayed until 1964. That fall he began a new job as an administrative assistant at Washington High School in Washington, Illinois. Eventually, Torry held the dual position of principal and superintendent for the Washington school system. With this position of power, Torry became an advocate for girls' interscholastic sports. He believed that girls could play sports on a competitive level. Torry wanted to make sure that all of the students at his school had an equal opportunity. He was part of the Illinois High School Association Sports Advisory Committee during the late 1970s and early 1980s. Torry's position on the committee helped him promote athletics for girls. In 1977 the girls' basketball team at Washington High School placed second in the first girls' basketball tournament in Illinois. Torry was interviewed as the primary administrator at Washington High School because of the early and untimely death of the coach who led the team to the inaugural I.H.S.A. girl's basketball tournament, Jan Smith.
